Program Specifics (Quick Overview)

- PL 106-554 authorized the COE to provide technical and financial assistance to carry out projects for the planning, design and construction of treatment works to improve water quality in the Florida Keys National Marine Sanctuary.
 - □ Federal funding limit Authorization: \$100,000,000.
 - □ Federal/non-Federal split: 65% Fed / 35% non-Fed
 - Non-Federal funding: \$53,800,000
 - Total Program cost: \$153,800,000
- Distribution: Determined by the Intergovernmental Task Force in 2000-2001.
 - ☐ Key Colony Beach \$200,000
 - Layton \$800,000
 - Key West \$10,320,000
 - Key Largo/Marathon/Islamorada \$29,560,000
 - □ Total \$100,000,000





Funding Update

- Total Reimbursed as of February 2016: \$46,722.336.35.
 - Key Colony Beach: \$196,996.00 (100% reimbursed of their allocation)
 - □ Layton: \$782,238.00 (100% reimbursed of their allocation)
 - Key West: \$9,875,923.00 (100% reimbursed of their allocation)
 - Islamorada: \$3,008,219.70 (\$25,282,974.30 remaining in their allocation)
 - □ Marathon: \$16,452,489.49 (\$11,838,703.51 remaining in their allocation)
 - □ Key Largo: \$16,406,470.16 (\$11,884,723.84 remaining in their allocation)
- In October 2014, an Interlocal Agreement was executed by Islamorada, Marathon and Key Largo which stated that 50% of future allocations will go to Islamorada until they reach the amount they gave to other municipalities in ARRA funding (\$7M).
- After Islamorada is made whole, future allocations will be split equally between the three municipalities.





Funding Update

- In FY 2015, FKWQIP received \$2,000,000 from work plan funding (environmental infrastructure funding).
 - □ \$1,000,000 Islamorada
 - □ \$500,000 Key Largo
 - □ \$500,000 Marathon
- In FY 2016, FKWQIP received \$3,000,000 from work plan funding (environmental infrastructure funding).
 - □ \$1,499,000 Islamorada
 - □ \$749,000 Marathon
 - □ \$749,000 Key Largo
